

EXPRESS CONSENT FOR THE PROCESSING OF PERSONAL DATA

Your data **will be used in a lawful way, with loyalty and transparency. You will have the right to withdraw your consent at any time with the same ease with which you gave it but with the applicable Regulatory and Legal limitations.**

You will have the right to file a claim with the Spanish Data Protection Agency (control authority). Your data **will not be processed for profiling purposes.** You may receive within a **period of no more than 72 hours notice of any incident or breach regarding the security of your data.**

Likewise, I inform you of the possibility that you have to **exercise the rights of access, rectification, deletion, limitation of treatment, portability and opposition of your personal** by writing to: **LINO JOSÉ GARCÍA NORIEGA: 36 Castelló Street, 1st floor, apartment A.
